Postgraduate students who enroll into courses provided by other departments must obtain approval from their supervisor or the head of the Graduate School by their signature on the enrollment sheet. Only credits earned from courses provided by this Graduate School are counted towards graduation credits. 2. The optional courses on this list of compulsory and optional courses can be applied retroactively to students enrolled before the 102th academic year. 3. The newly added regulation regarding compulsory and optional courses is applicable to students enrolled before the 102th academic year. 4. The total credits from courses enrolled by postgraduate students (excluding pre-courses and mending courses) shall not be less than 3, nor exceed 25. The minimum credits requirement aforementioned is not applicable to students who are in their extended period of study, nor to returned students, if one fourth of their required credits is offset. Other exceptional circumstances concerning the credits requirement are subject to the approval by the Head of the Department. 5. Postgraduate students of this Graduate School must enroll into the compulsory and optional courses and earn a minimum of 38 credits (excluding credits earned from their dissertation for degree), and pass examinations required by the Regulation of Postgraduate Degree Examination of this University and departmental professional basic competency tests (failing which will be subject to alternative evaluation measures) before they can graduate. 6. Students of the Master Program must satisfy the University's English Competency Assessment Regulation in order to qualify for graduation. The courses of "Practical Legal English 1" and "Practical Legal English 2" can be deemed equivalent to the courses of "Practical Applied English 1" and "Practical Applied English 2" required by the above Regulation. 7. The listed optional courses are provided in accordance with the relevant regulations of the University, and are subject adjustment according to the actual enrollment of each semester.
